DEPARTMENT REPORTS:

FIRE DEPT.:

addresses are hard to find. They cost around \$120.00 to \$150.00. Andy made a motion to purchase the Garmin G.P.S., Starleen seconded it and the motion carried.

FIRE DEPT. AUXILIARY:

The Fund Raiser for the new complex was held on Aug. 24, 2013. There were lots of things to do including kids games. The Hope Methodist Church ladies did a bake sale for us. Gene Smith and his band entertained the people and were great. We had a DJ out by the live auction and he entertained the younger crowd. Floyd Andrick was at the First Aid station and free blood pressures were given. Our auctioneers were Steven Braley & Sippi. A thank you to Mike Braley, who kept the bidding interesting. PARK COMMISSION:

The equipment costs \$9,730.00, the park commission is asking the township to go half with them to finish the purchase and not lose the grant. WATER:

CHAPEL/ CEMETERY COMMISSION:

The commission met before the Board meeting. Items discussed were- (1) Where will green burials and cremations be located. We are working on a garden to incorporate them in. (2) The light and flag pole will be located on the west side of the chapel. (3) The benches to be purchased for the cemeteries have not been located yet. We may have to wait for next season to find some. (4) We are still getting bids for the new roads in the new cemetery. (5) Kathy is going to try a new paper she has found in the glass windows. (6) We are waiting for the roads to be completed to mark out new section. (7) The concrete slab has been poured for the dumpster in new cemetery. (8) The willow trees that were cut down in the old cemetery have been removed by residents to use the wood. (9) Floyd went back to the census of 1894 to find the names of residents to use their names for roads in both cemeteries. The new cemetery we are thinking of Wilson- Mathews for the main road. The old cemetery, we are looking at Havens-Fillmore for the main road. These have not been set in stone yet and suggestions will be taken into consideration. A question was raised if we could put the info on our website. This will be looked into.

TOWNSHIP CODE AUTHORITY:

There were 9 permits for our township. These will be going up as the water lines get completed. The office hours have gone back to the original times. The new hours did not work for the contractors. Sept. 26 is the next meeting at the county building.

WIXOM LAKE ASSOC. REPORT:

The work is done for this year. There will be a meeting Sept. 11 at the Billings Twp. Hall. The state has decided there will be no drawdown this year on Wixom Lake.

ROAD ADVISARY COMMISSION:

There will be a meeting to look at how much money is left and what road projects will be considered for next year.
