FIRE DEPT.:

There were 6 runs in March, there were 3 medical runs, 1 good intent and 2 fire runs. Cliff will be applying for a DNR grant for purchasing wild fire coats. The Federal Government have said they will give Fire Dept.'s a free new generator. Ours is old and needs to be updated. The Chief would like to order more shirts and jackets. Two firemen have taken their state tests and are now qualified as EMS's. Two more firemen are ready to take their tests. We are proud of our fire dept., they go above and beyond what is asked of them. TRAINING AVAILABLE THIS MONTH: Hope will assist Mills in training for the Jaws of Life. Homer will have training for Farm Accidents. Mills through the DNR will have training for wild fires. We have approximately 12 to 15 firemen available for fire calls. We are fortunate to have this many as some of the departments do not have many to be counted on.

PARK COMMISSION:

They held their meeting Mar. 3, 2015 at the hall. Work will be done on Pavilion A this spring. The pavilion will be painted and the picnic tables refinished. This will be paid from the grant from the Kiwanis Group. Andy had applied for a grant from Midland Area Community Foundation for doing the handicap parking in front of the bathrooms. He applied for \$8,000.00 and that is what he was granted. Starla has the bids from last year and will check to see if they will honor their bids this year. She is also working on matching funds for the \$8,000.00. This can be in money, donated work time or supplies.
