DEPARTMENT REPORTS:

**FIRE DEPT:**

Jan. there were 15 runs. Medical-7, Fire-1, Public Assist-1, Good Intent-2 and Lift Assist-4. Dustin Drabek was at the township for a risk control visit. They investigate the areas and report if anything could be handled differently to prevent an accident or injury. It was recommended that all firemen have physicals annually. It also, was recommended to use township property rather than a private person's property for training and hose testing. Mike Coston is working on the constitution update. It will be ready soon for consideration.

**PARK:**

The park is closed until April. Consumers have been doing replacement work on the property. They have made several deep trenches and will repair them when weather permits.

**PLANNING COMMISSION:**

Their meeting was held Feb. 1 with Rodney Nanney. Rodney is working on updating parts of the master plan. This is a requirement of the state.

**CHAPEL/CEMETERY:**

Howdens have done a great job at keeping the snow plowed and not piling snow by the driveways. There are several trees that need to come down by the ditch. Andy will call Consumers and see if this is something they do. They will get back with us.

**TOWNSHIP CODE AUTHORITY:**

The meeting was held Feb. 23 at the county building. Hope township had 3 building permits and 1 electrical. Weiss Township from Isabella County has joined the code authority.

**ROAD ADVISORY COMMISSION:**

The Road Commission met Feb. 2, 2017. Jerry Clark was present to see if anything could be done for Adams Rd. from Five Mile to M-30. Discussion was held and it was recommended to look at Adams Rd. next year to have the County Road Commission decide what would be necessary to get the road ready for road work. The ditches have not been touched in several years. Andy will contact the County Road Commission to have them get an estimate of time and cost for Adams Road. JoAnn made a motion to do Hull Road work this year and look at Adams rd. in next year's work. Starleen seconded the motion and a roll call vote was called-
